# Heritage Transaction Fund 2018 Small Grant Program for Closing the Deal

The Last Green Valley, Inc. (TLGV) is pleased to announce a new source of grant funds for the region's non-profit organizations, cities and towns. The small grants can be used to help pay closing costs for projects that will permanently protect National Heritage Corridor resources.

TLGV is a member-supported, non-profit organization working to care for and pass on The Last Green Valley so future generations can continue to enjoy the National Heritage Corridor.

#### **Eligible Projects**

Projects that will permanently protect significant historic properties or structures, agriculture or forested lands, important wildlife habitat, or open spaces suitable for passive, nature-based recreation are eligible.

The grant funds can be used for closing costs (filing fees, title work, attorney fees), surveys, appraisals, and other costs associated with projects that are "nearing the home stretch" and need additional funds to complete the deal.

Grants will range from \$2,000 - \$3,000 and must be spent within a year of approval. Funds will be dispersed on a reimbursement basis and must be matched at least 1:1 by cash or in-kind contributions. Projects that demonstrate significantly greater ratios of non-federal matching funds will score higher.

#### **Eligible Organizations**

Municipalities and non-profit 501(c) organizations are eligible to apply for projects located within The Last Green Valley National Heritage Corridor. Organizations that are awarded heritage transaction funds in 2018 will not be eligible to apply in 2019.

#### **Application Deadline**

Applications must be postmarked, hand-delivered, or emailed to <a href="LyAnn@tlgv.org">LyAnn@tlgv.org</a> by 4 pm on Thursday, June 14, 2018. TLGV will confirm receipt of all applications within 2-3 business days. Successful applicants will be notified within three weeks of the deadline.

#### The Fine Print

- For all grants, payment of expenses will be made on a reimbursement basis.
- A 1:1 match of cash or in-kind contributions (such as volunteer labor or donated supplies) must be demonstrated. Projects with significantly more non-federal match will score higher.
- Incomplete applications will not be considered. Applications will be evaluated by a selection committee whose members will recommend their decision to the TLGV Executive Committee and/or TLGV Board of Directors for final approval of awards.
- TLGV reserves the right to fund projects at a level less than requested.
- Applicants that are awarded funds will be expected to meet with TLGV and sign all necessary paperwork by September 30, 2018. TLGV funds cannot be spent until a contract has been fully executed.
- Funds must be expended by September 30, 2019.
